Old Business:

a) Sweet Home Sleeping Shelter Proposal

City Manager Ray Towry introduced the issue of homeless and provided the Council with various documents including House Bills and Case Law to explain the limitations the City has for excluding anyone from sitting or sleeping in public places if there is no adequate temporary shelter available. City Attorney Robert Snyder further explained Martin v. Boise "Right to Rest" and HB 3115 and HB 2006. Community and Economic Development Director Blair Larsen spoke about HB 2006 stating any emergency shelter is exempt from the Land Use Process if they comply with the provisions of the bill, noting that law is set to sunset July 1, 2022.

Staff presented photos of the current issues due to homeless camps near the Sweet Home Fire Department. Public Works Director Greg Springman explained the cost related to daily cleaning of the public spaces.

Police Chief Jeff Lynn provide Police Department statistics over the last 5 years involving homeless and the challenges the officers are dealing with.

There was at time for questions and discussion from the Council.

Nancy White, 911 6th Avenue. Concerned about how the facility would be funded.

Josh Thorstead, 1210 44th Avenue. Also concerned about how the facility would be funded and who will be accountable when the facility fails.

Robert Edger, Ridgeway Road questioned the difference between a hight barrier and low barrier facility.

Brock Byers, FAC spoke regarding funding for the Sweet Home Sleep Center.
