# **Recognition of Visitors and Hearing of Petitions:**

a) Rural Development Initiative (RDI) Presentation

The Rural Development Initiative Sweet Home Youth Leadership Program reported on their work in the community. Students AJ Rodrigues and Tea Herrera presented a project for the betterment of the community on mental health awareness. Mayor Mahler stated mental health awareness is important and he commended their bravery for coming forward and giving their testimony. Christine Gilmore, RDI Director talked about the benefits of the Youth Leadership Program in Sweet Home.

#### **Old Business:**

a) Request for Council Action – Radiator Supply Request

Motion to table the request and request the Administration, Finance, and Property Committee recommend a policy regarding these types of donation requests made by President Pro Tem Gerson, Seconded by Mayor Mahler.

b) Request for Council Action - Intergovernmental Agreement with Linn County for Proposed RV Sewage Disposal Facility

Staff presented an agreement that was acceptable by Linn County that would include donating property to FAC for the unsheltered and retaining a portion for an RV sewage disposal site. An easement on City property on 24th avenue would be necessary for power, telecommunications, and a waterline. Other improvements would include pavement with a gravel base, multi-use path, drainage swales, concrete ribbon to the protect road base, and lamp posts. There would be a cost share with approximately \$106K being paid by Linn County for roadway improvements and the City and FAC to pay for the remaining improvements estimated at \$77K.

Brock Byers and Shirley Byrd read a statement to the Council that FAC is prepared to move forward without support of the City and withdraw from their agreement with the City if the IGA with Linn County is not signed.

Motion made to approve the Intergovernmental Agreement with Linn County for the proposed RV Sewage Disposal Facility by President Pro Tem Gerson, Seconded by Councilor Gourley.
