- Make motions, debate, and speak in general only once the Chair has acknowledged you.



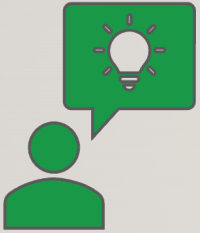
2. Debate only after a motion has been made

- Say **exactly** what you mean to say when making a motion.

# ROBERT'S RULES OF ORDER

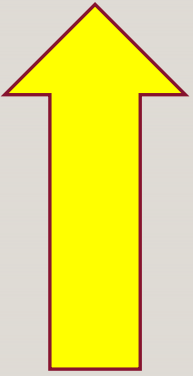
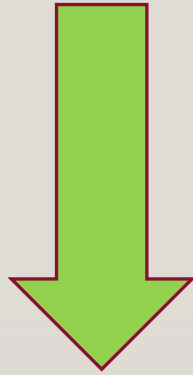
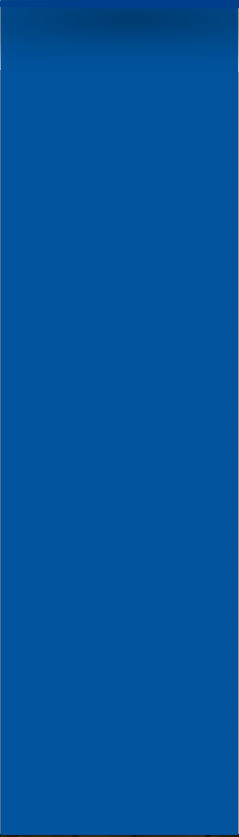
## 3. Second does not mean “agree”

- Seconding a motion means that at least two people want the topic brought to the floor for discussion, not that the parties agree that the motion is a good idea.



## 4. Debate ideas, not people

- Stick to facts and ideas when debating. Avoid personal attacks and keep things civil. Be aware of any established time limits to debate.

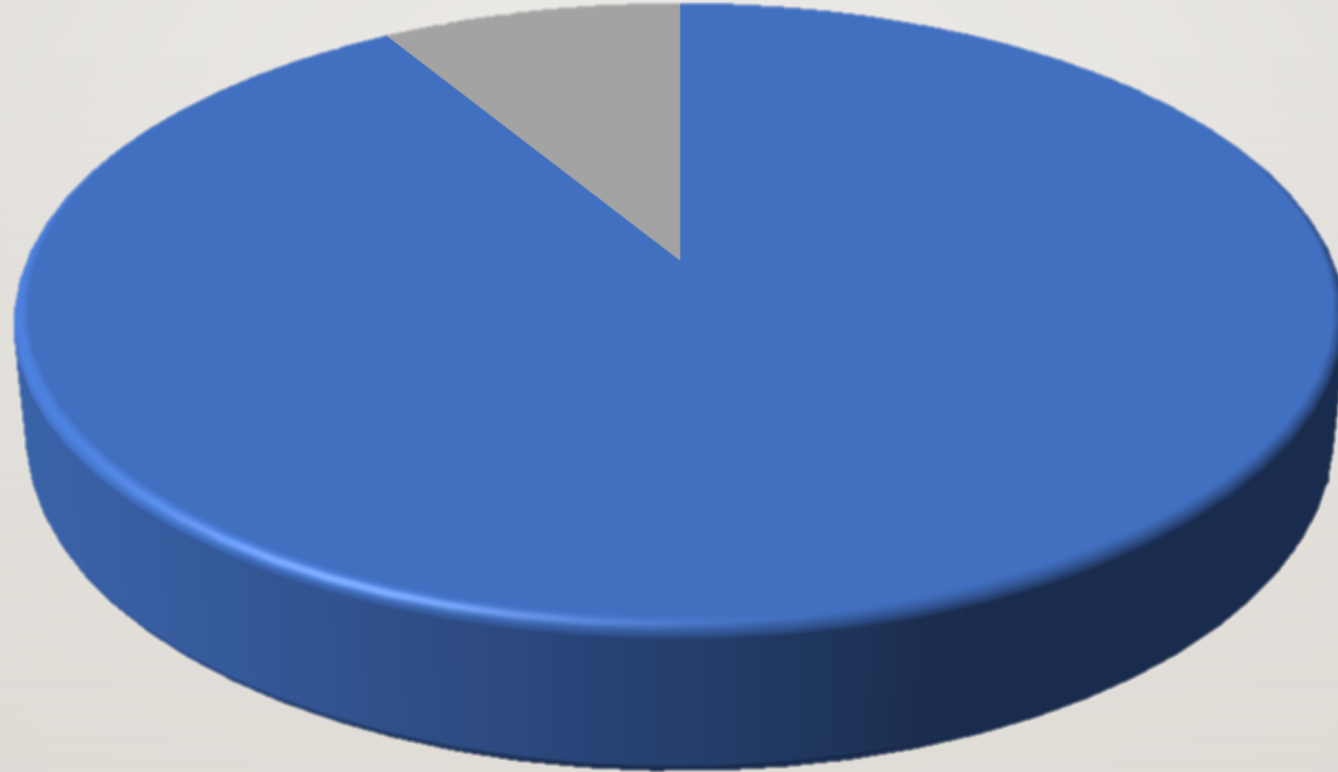

# SWEET HOME POLICE DEPARTMENT STATISTICS

- Sweet Home's Current Population: **9,828**
  - Homeless Population: **41** (*0.4% of total population*)
- YTD Total Calls: **6,120**
  - Calls Involving Homeless: **579** = **9.46%**
  - Homeless Calls Resulting in Arrest:
- YTD Total Arrests: **611**
  - Total Homeless Arrests: **109** = **17.84%**

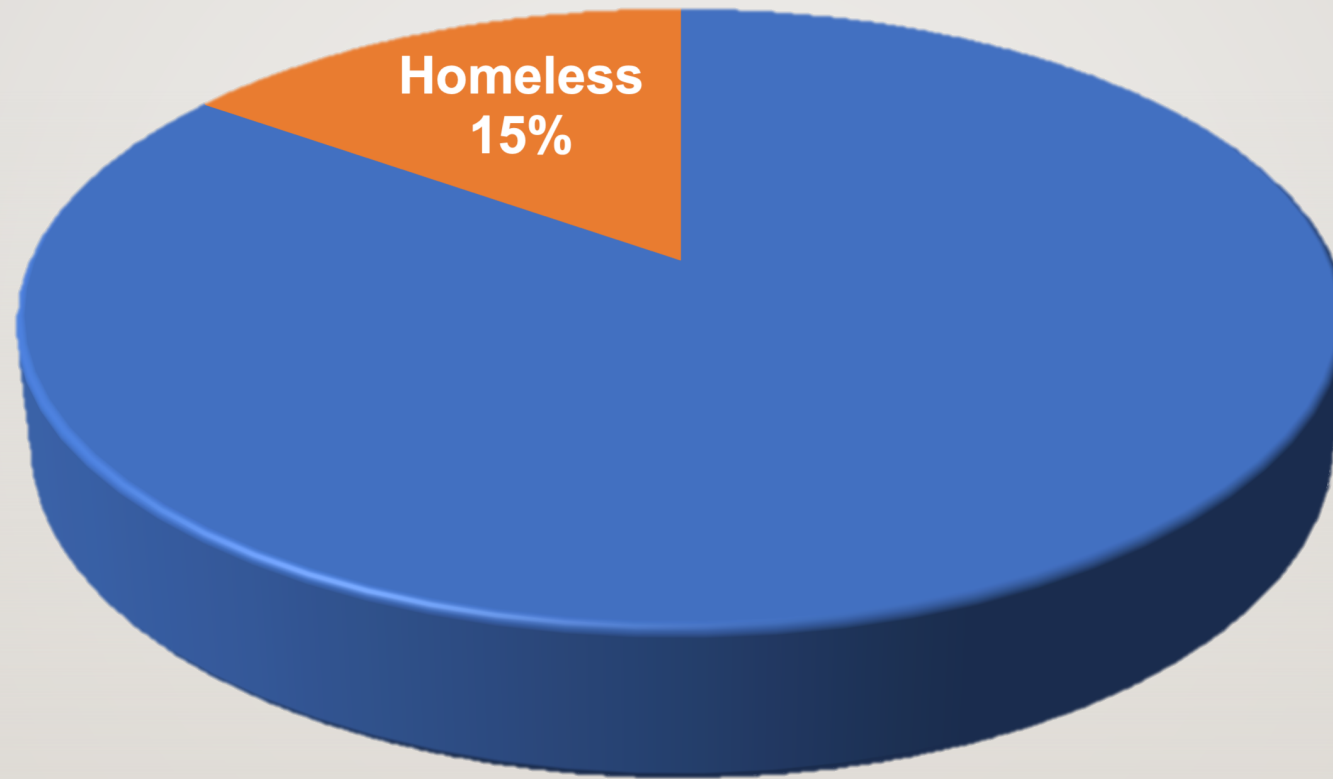

# YTD\* ARRESTS



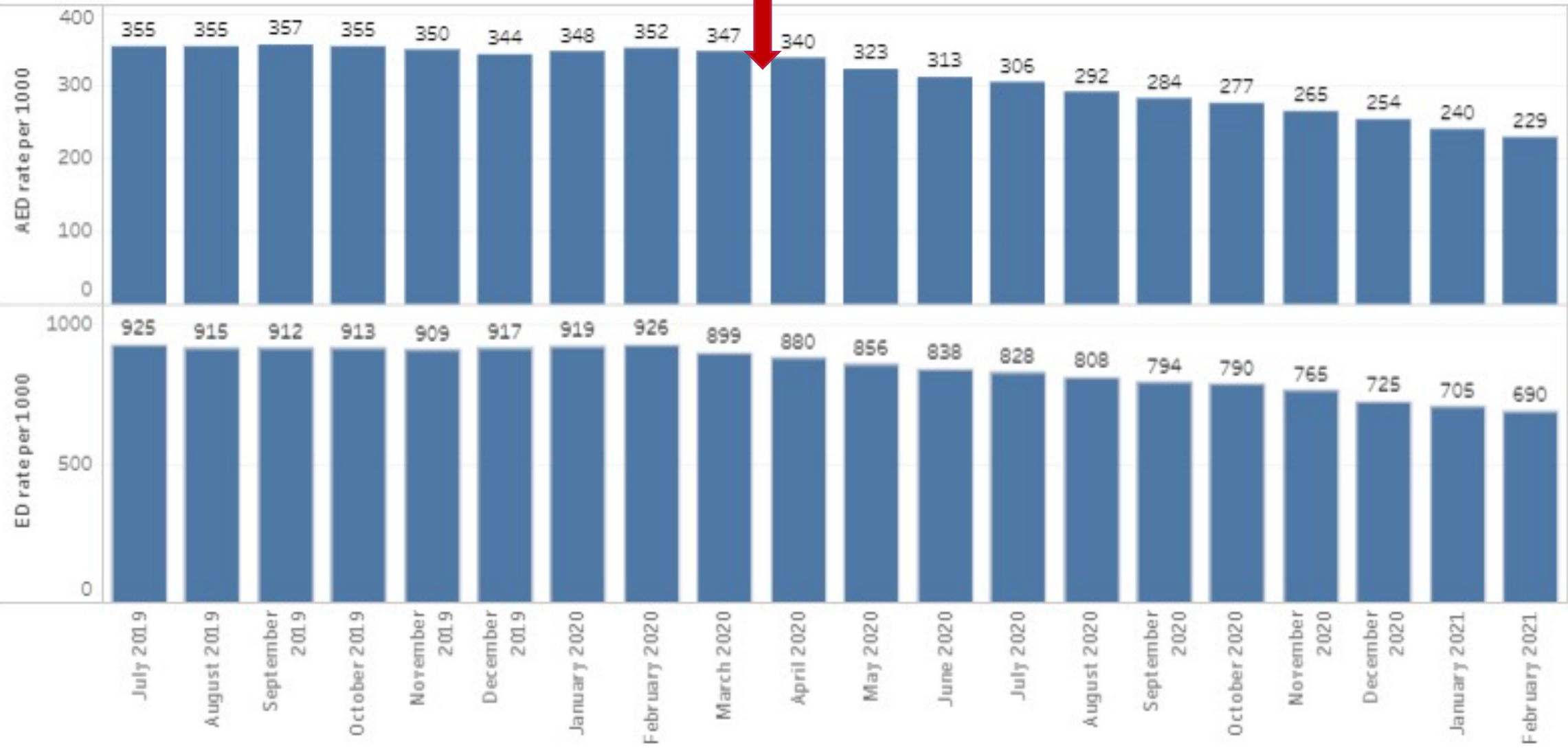

# INNOVATIVE

This pilot program would be modeled after the Walla Walla, Washington site and will operate by the guidelines adopted by the City of Sweet Home and its leadership. Will provide emergency housing and programs that facilitate actions from low barrier emergency housing to transitional housing and eventually permanent housing.

THE FACILITY WOULD BE MANAGED, SECURE AND HAVE RULES THAT REQUIRE CLEANLINESS AND ORDER.
