## ORDINANCE BILL NO. 11 FOR 1982 ORDINANCE NO. 867

AN ORDINANCE REPEALING ORDINANCES NUMBERED 74, 123, 249, 261, 295, 381, 489, and 592.

WHEREAS, the ordinances hereinafter repealed are obsolete and unnecessary;

THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:

- Section 1. Ordinance No. 74 entitled "Regulating the Burning of Refuse From Plants or Sawmills within the Limits of the City of Sweet Home; Prescribing a License for Such Refuse Burning; and Providing a Penalty for the Violation of this Ordinance" is hereby repealed.
- Section 2. Ordinance No. 123 entitled "Providing for the Establishment of a Building Setback Line on the South Side of "M" St.; Providing a Penalty for the Violation thereof" is hereby repealed.
- Section 3. Ordinance No. 249 entitled "Providing for the Payment of Disability Allowances to Volunteer Firemen of the City who Sustain Disability by Reason of Illness or Accident Resulting from the Performance of their Duties as Volunteer Firemen" is hereby repealed.
- Section 4. Ordinance No. 261 entitled "Regulating Installation, Repair and Maintenance of Television and Radio Receiving Antennas; to License and Regulate Persons Installing the Same; Providing Penalties for Violation hereof" is hereby repealed.
- Section 5. Ordinance No. 295 entitled "Providing for the Establishment of a Building Setback Line on the North Side of "M" St.; Providing a Penalty for the Violation Thereof" is hereby repealed.
- Section 6. Ordinance No. 381 entitled "Providing for the protection of the Public Health by the Licensing of Persons Engaged in the Business of Plumbing or Laboring at the Trade of Plumbing; Requiring a Permit for the Installation or Alteration of and Prescribing the Minimum Requirements for the Installation of Alteration of Plumbing and Drainage Systems, and the Inspection thereof; Providing Penalties for Violations; Repealing Ord. No. 138 and 145" is hereby repealed.
- Section 7. Ordinance No. 489 entitled "Adopting a Fire Prevention Code Prescribing Regulations Governing Conditions Hazardous to Life and Property from Fire or Explosion, and Repealing Ord. #387" is hereby repealed.
- Section 8. Ordinance No. 592 entitled "Prescribing a License for Building Contractors, Providing Penalties for Violation thereof, Repealing Ordinance #426" is hereby repealed.
