ORDINANCE NO. 1046

AN ORDINANCE OF THE CITY OF SWEET HOME OREGON
ADOPTING THE SWEET HOME MUNICIPAL CODE
AND DECLARING AN EMERGENCY

WHEREAS, The City of Sweet Home has had compiled, edited and published a codification of the permanent and general ordinances of the City of Sweet Home, Oregon;

The City of Sweet Home does ordain as follows:

Section 1. Adoption. There is hereby adopted the "Sweet Home Municipal Code," as compiled, edited and published by Book Publishing Company, Seattle, Washington.

Section 2. Title--Citation--Reference. This code shall be known as the Sweet Home Municipal Code and it shall be sufficient to refer to said code as the Sweet Home Municipal Code or SHMC in any prosecution for the violation of any provision thereof or in any proceeding at law or equity. It shall be sufficient to designate any ordinance adding to, amending, correcting or repealing all or any part or portion thereof as an addition to, amendment to, correction or repeal of the Sweet Home Municipal Code. Further reference may be had to the titles, chapters, sections and subsections of the Sweet Home Municipal Code and such references shall apply to that numbered title, chapter, section or subsection as it appears in the code.

Section 3. Reference Applies to All Amendments. Whenever a reference is made to this code as the Sweet Home Municipal Code or to any portion thereof, or to any ordinance of the City of Sweet Home, Oregon, codified herein, the reference shall apply to all amendments, corrections and additions heretofore, now or hereafter made.

Section 4. Title, Chapter and Section Headings. Title, chapter and section heading contained in the Sweet Home Municipal Code shall not be deemed to govern, limit, modify or in any manner affect the scope, meaning or intent of the provisions of any title, chapter or section hereof.

Section 5. Reference to Specific Ordinances. The provisions of the Sweet Home Municipal Code shall not in any manner affect matters of record which refer to, or are otherwise connected with ordinances which are therein specifically designated by number or otherwise and which are included within the Sweet Home Municipal Code, but such reference shall be construed to apply to the corresponding provisions within the Sweet Home Municipal Code.

Section 6. - Ordinances Passed Prior to Adoption of the Code.
The last ordinance included in the Sweet Home Municipal Code was Sweet Home Ordinance 1039, passed January 14, 1992. The following ordinances, passed subsequent to Ordinance 1039, but prior to adoption of this code, are hereby adopted and made a part of the Sweet Home Municipal Code: Sweet Home Ordinances 1040, 1041, 1042, 1043, and 1044.


Section 7. - Effect of Code on Past Actions and Obligations.
The adoption of the Sweet Home Municipal Code does not affect prosecutions of ordinance violations committed prior to the effective date of this code, does not waive any fee or penalty due and unpaid on the effective date of this code, and does not affect the validity of any bond or cash deposit posted, filed or deposited pursuant to the requirements of any ordinance.

Section 8. - Constitutionality. If any section, subsection, sentence, clause or phrase of the Sweet Home Municipal Code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of the Sweet Home Municipal Code.

Section 9. - Original Ordinance Status. Any original ordinance that is or shall be passed by the Council of the City of Sweet Home shall be in full force and effect as stated therein. The Sweet Home Municipal Code facilitates their usage and if necessary the original ordinance may be referred to and used to accomplish the necessary function, prosecution or abatement.

Section 10. - Emergency Clause. It is hereby adjudged and declared that existing conditions are such that this ordinance is necessary for the immediate preservation of the public, peace, health and safety. Therefore, an emergency is hereby declared to exist, and this ordinance shall take effect and be in full force and effect from and after its passage and approval of the Mayor.
