

AN ORDINANCE INITIATING THE Street IMPROVEMENT DISTRICT # 6  
FOR: 2nd Avenue from Highway 228 (Holley Road) north to its dead end  
AND DECLARING AN EMERGENCY.

WHEREAS, the City Council has heretofore, on July 25, 1978  
by Resolution No. 29 for 1978 directed the preparation  
of plans and cost estimates for said proposed street  
improvement, and

WHEREAS, the Council did examine and consider said plans and  
cost estimate; and

WHEREAS, on January 23, 1979, by Resolution No. 3  
for 1979, the Council did appoint a Board of Viewers for the  
purpose of investigating said plans and cost estimates, and said  
Viewers filed their reports with the City Recorder on February 5,  
1979.

WHEREAS, notices of said reports as filed were thereafter give  
in accordance with Ordinance No. 505, and a public hearing was held  
on February 27, 1979; and

WHEREAS, the Council, being fully advised therein finds it is  
just and reasonable and in the best interest of the City of Sweet  
Home to install such street improvement;

NOW, THEREFORE, THE CITY OF SWEET HOME DOES ORDAIN AS FOLLOWS:


Section 1. The estimated assessments for such improvement are  
as shown on the attached supplementary report.

Section 2. The estimated assessments set out above are hereby  
declared to be just and proper assessments to the property abutting  
thereon and benefitted thereby.

Section 3. WHEREAS, it is necessary, and it is for the intere  
and benefit of the City that this ordinance become effective immedi  
an emergency is hereby declared to exist and this ordinance shall b  
full force and effect after the passage by the Council and approval  
by the Mayor.
