

ORDINANCE BILL NO. 16 FOR 1997

ORDINANCE NO. 1113

AN ORDINANCE CONCERNING SWEET HOME MUNICIPAL CODE SECTIONS THAT ADOPT OREGON REVISED STATUTES AS PART THEREOF AND DECLARING AN EMERGENCY

The City of Sweet Home does ordain as follows:

Section 1. 
