## ORDINANCE NO. 1128

AN ORDINANCE AMENDMENT PERTAINING TO SKATEBOARDS, BICYCLES, INFRACTIONS, AND DECLARING AN EMERGENCY

The City of Sweet Home does ordain as follows:

Section 1. Sweet Home Municipal Code Section 10.20.010 is amended to read as follows:

## 10.20.010 Use of Roller Skates and Skateboards -- Restricted.

No person upon in-line skates, roller blades, skates, skateboards or riding in or by means of any coaster, toy vehicles or similar device shall go upon any street or area or premises open to the public where such use is prohibited and no person shall use said devices upon any sidewalk restricted from bicycle use under SHMC Section 10.24.010 or on any City owned or operated parking lot.

Section 2. <u>Sweet Home Municipal Code Section 10.24.010 D</u> is amended to read as follows:

D. No person shall ride or operate any bicycle on any sidewalk on Main Street between 9th Avenue and 18th Avenue; on Long Street between 10th Avenue and 15th Avenue; on 10th Avenue, 12th Avenue, 13th Avenue and 15th Avenue between Long Street and Main Street of the City except bicycles used for delivery of papers, merchandise or mail, and except such vehicles with more than two wheels used by a disabled person. Pedestrians shall have the right-of-way over bicycles on all sidewalks. No person shall ride or operate any bicycle on any sidewalk in a careless manner, or in any manner that endangers the safety of the pedestrian or places a pedestrian in fear of his safety. No person shall ride or operate any bicycle on any area or premises open to the public where such use is prohibited.

Section 3. Violation of Sweet Home Municipal Code Chapter 10.20 may be prosecuted under the provisions of Chapter 9.36 of the Sweet Home Municipal Code pertaining to Infractions. Infractions in the Sweet Home Municipal Ordinances and Sweet Home Municipal Code Sections, including this Ordinance, shall be hereinafter referred to as Violations with a fine not to exceed \$300.00 and have the same force and effect as the Infractions designated therein except as specifically amended hereby. The infraction procedures set out in Sweet Home Municipal Code Chapter 9.36 shall forthwith comply with the provisions of Oregon Laws 1999 Chapter 1051 Section 2 through 29 inclusive. Any infraction procedures set forth in Sweet Home Municipal Code Chapter 9.36 that are in conflict with State Law or this Section are hereby repealed with the remainder if any of Chapter 9.36 remaining in inviolate to be used in conjunction with the Sweet Home Ordinances and Code Sections that were Infractions. All Municipal Court cases in process shall remain inviolate and not be affected hereby. For Violations Enforcement Officers include City Code Enforcement Officer(s) and designates, Building Official(s) and designates, and Fire Chief and designates.

Section 4. Emergency Clause. It is hereby adjudged and declared that existing conditions are such that this ordinance is necessary for the immediate preservation of the public peace, health and safety. Therefore, an emergency is hereby declared to exist, and this ordinance shall take effect and be in full force and effect from and after its passage and approval of the Mayor.
