RULES & RESERVATIONS

Applicant and all of his or her family must abide at all times by rules, regulations and policies adopted by the City of Sweet Home Racquet Court relating to use and upkeep of the club facility. Failure to abide by these rules, regulations and policies shall be grounds for termination of membership. Rules, regulations and policies may be changed or altered from time to time; all such changes or alterations shall be posted in the court. Until changed the following rules, regulations and policies shall be in effect.

- Court hours are from 6am until 10pm
- All participants must have a current membership card
- All children under the age of 18 must be accompanied by an adult
- Shirts and shoes are required
- All injuries must be reported
- Food, drink, gum, tobacco, and other such items are not permitted on the court
- Avoid striking the court walls with racquets
- No bicycles, skateboards, etc., allowed
- The court is open on a first come first serve basis, unless the court is reserved
- Reservations can be made for one hour
- The court may be kept longer if a reservation has not been made for the court for the time slot following
- If the court is not claimed within 10 minutes of reservation time, it becomes available to others
