



Peer Court



The Sweet Home Peer Court Program is an opportunity for first or second time juvenile offenders to avoid formal prosecution by appearing before a court of their peers.

Sweet Home Peer Court handled 20 cases in the 2014-2015 sessions so far. Student volunteers assessed Community Service or Sweet Home PD Work Crew in 50%

of those cases processed. This resulted in 33 hours of

Community Payback Service (CPS). CPS has to be done at a local non-profit organization or helping an elderly person with tasks. Most of the cases heard have been Curfew Violations and Runaway Reports. Peer Court currently has 6 Junior High and High School student volunteers. Of the current student volunteers, 2 came through Peer Court themselves and decided to remain as an active volunteer once their sanctions were complete. Their duties include, Judge, Presenter, Court Clerk, Bailiff and Juror.

Perscription Drug Take Back

In 2014, our department continued its efforts to collect and dispose of unused/unwanted prescription medications. We again participated in the National DEA Take Back program and shipped 7 boxes of medication for destruction. Our disposal drop box was used throughout the year as well. A total of 10 boxes were collected as a result of having a convenient disposal drop box available to the public. Each of these boxes averaged 45 pounds in weight for a total of approximately 450 pound of unused/unwanted medications that were safely destroyed.



SHPD Volunteers

The Sweet Home Police Department started a volunteer program in 2014. We modeled our program after the National VIPS (Volunteers in Police Service) program. We received 21 applications and had 18 active volunteers throughout 2014. At least half of our volunteer pool came for our 2013 Citizen's Academy class graduates. Students saw the need to assist their local police department and are encouraged to become part of our team. Some of the responsibilities and details they were involved with in 2014:








Property Crimes
